A. INVITATION TO NOMINATE

The current National Council Treasurer (NCT) will complete his two-year term in office, and it is time to elect a new treasurer.

The position of NCT is open for nominations. National Council ("NC") formally invites all members to participate in the nomination of candidates for the position.

The NCT is a crucial member of our NC Executive Committee and plays a vital role in ensuring the financial health of our Society. We are looking for a dedicated member who not only possesses the necessary qualifications but also shares the mission and values of our Society.

We urge all interested members to discern and consider this opportunity and submit the nomination form to the National Council Secretary's email - lisa.lim@ssvpsingapore.org , as soon as possible. The nomination form should reach us not later than **Tuesday, 11 April 2023 by 11:59PM.**

In compliance with SSVP Constitution, extracts for reference:

5. *Election and Management of National Council and ExCo of National Council:*

5.2 *Eligibility:*

Any member of the Society may be nominated to be appointed as a National Council member subject to him/her meeting the following criteria:

- a. *He/she must not be over the age of 71 years at the time of nomination;*
- b. *He/she must not have any previous criminal record (other than minor traffic offences); and*
- c. *He/she must not be an undischarged bankrupt*

5.6 *Election and Appointment:*

(b) The National Council Treasurer shall be elected through majority of secret votes cast by the Society's full members.

The election of those positions as referred to in clause ...5.6(b) above shall take place at an Annual General Meeting or an EGM called by the National Council ExCO where the votes are counted.

5.7 *Term of Office:*

(b) Treasurer: The term of office of a National Council Treasurer shall be 2 years. An incumbent Treasurer may be re-elected for a further term of 2 years. Provided always

that a National Council Treasurer shall not hold office for a consecutive term of more than four years and may be nominated for election as a Treasurer again only after a lapse of at least 2 years from the date of cessation of his/her previous term as National Council Treasurer.

B. TIMELINE FOR NOTICES

A period of one month shall lapse between the nomination of candidates and the election. During the period of election, members are invited to pray for the candidates who are prepared to accept their responsibilities.

At least two (2) weeks' notice shall be given of an Annual General Meeting and at least ten (10) days' notice of an Extraordinary General Meeting of the Society.

Any member who wishes to place an item on the agenda of a General Meeting may do so provided he gives notice to the National Council General Secretary two (2) weeks before the meeting is due to be held.
